- 1.*I understand that I am responsible for any harm caused by my dog while my dog is attending The Executive Dog, Inc. I shall indemnify The Executive Dog, Inc. against any claims made against the corporation or losses or damages of any kind suffered by The Executive Dog, Inc. as a result of my failure to inform The Executive Dog, Inc. of any pre-existing condition the dog may have (such as illness or aggression problems.) I understand and agree that in admitting my dog to The Executive Dog, Inc. the facility has relied on my representation that my dog is in good health and has not harmed or shown aggressive or threatening behavior towards any person or any other dog.
- 2.*I understand and agree that The Executive Dog, Inc. will not be liable for problems, damage, or injury caused by my dog provided reasonable care and precautions are followed by staff. I understand that The Executive Dog, Inc is fully insured. I release The Executive Dog, Inc. of any liability arising from my dog's attendance and participation at the daycare facility.
- 3.*I understand and agree that any problem or injury that develops with my dog will be treated as deemed best by The Executive Dog, Inc. Either my veterinarian or our mobile veterinarian will be contacted in the event of a medical problem that is serious in nature. The Department of Agriculture of Massachusetts requests that a plan be in place in the event your animal was to become deceased while in care of The Executive Dog Inc. I will be notified immediately of the situation and the body will be taken to Mattapoisett Animal Hospital or will be held at your request until your arrival.
- 4.*I understand that if my dog is left in the care of The Executive Dog, Inc. for a period of three days after the scheduled pickup date or time without contact from the owner this dog will be considered abandoned and necessary steps will be taken to turn the animal over to the proper authorities.
- 5.*I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include, but are not limited to, problems resulting from rough play, food scraps found outdoors and kennel cough (doggie colds).
- 6.*I, as the owner, agree to be solely responsible for any and all acts or behavior of my pet while in the care of The Executive Dog, Inc. If my pet should become ill or seem to be in need of medical consideration, The Executive Dog, Inc. reserves the right to administer aid and/or to use any available veterinarian. I, the owner, shall pay any expenses so incurred.
- 7.*DAYS AND HOURS: Monday through Friday from 7:00 a.m. to 6:00 p.m. The Executive Dog, Inc. is not an overnight facility. Staff goes off duty at 6:00 p.m. and there will be a \$5.00 charge per 5 minutes for any pet left after 6:00 p.m.
- 8.*RESERVATION: Required. Cancellations with less than 24 hours notice will be charged full fees.
